 - .3 Wil-can Electronics at 888.596.2020.
 - .3 Lightning protection system to be re-installed using roof friendly attachment and support methods to eliminate puncturing new roof membrane. Consultant MUST approve attachment and support methods prior to installation.
- .2 <u>Mechanical</u>: Contractor is responsible for all mechanical work necessary to complete the roofing work as specified, including removal and reinstallation of existing cooling tower as required.
